

Table of Business Category and Premium Applicable for the Occupational Accident of Labor Insurance

The amendment was promulgated on October 26, 2021 by the Ministry of Labor under reference Lao-Dong-Bao-3-Tze-1100140684.

The date of implementation is January 1, 2022.

According to Article 13, Paragraph 3 of the Labor Insurance Act, the occupational accident insurance premium rate is determined based on two premium types, i.e., Business Category Accident Premium Rate and On/Off Duty Accident Premium Rate. The premium rates are as follows:
